How to register

Conference registration occurs through the **Chillin' Competition website**, using the facilities of Eventbrite at **Ithaca Competition Summit**.

Seating is limited strictly to 120 participants. How to get there

To reach the Ionian island of **Ithaca**, you will need to arrive by either ferry or sea taxi as there is no airport on Ithaca. The closest airport is on the neighboring island of **Kefalonia** (Argostoli airport), which receives daily domestic flights from **Athens** (Aegean Airlines), and the trip takes just less than an hour. There are also many direct scheduled flights in summer from European airports to Kefalonia (including London, Amsterdam, Rome and various airports in Germany), as well as charter flights. After arriving by plane to Kefalonia, visitors can take the scheduled ferry service or arrange for a water taxi from the port of Sami to Ithaca.

The other airports worth considering are **Preveza** and **Araxos**, both on the mainland. These smaller regional airports have a number of charter flights during the summer season. From Preveza, one can drive easily over the bridge to the island of **Lefkada** and ferry to Ithaca, while from Araxos in the Peloponnese one can drive to the port of **Patra**, which has a daily ferry service to Ithaca.

Alternatively, one can drive (on the recently-opened motorway) from Athens airport to the west coast of the mainland and take a ferry from the ports of **Patra** (240kms), **Astakos** (320kms) or **Kyllini** (320kms). The ferries from Patra and Astakos go directly to Ithaca, while the Kyllini ferry goes to the port of Poros on Kefalonia, so you would need to drive to Sami to pick up the scheduled ferry or water taxis to Ithaca.

If you are interested in some island hopping, there is a flight service (**Sky Express**) from Corfu to Kefalonia, and a new hydrofoil island hopping ferry service which covers the Ionian islands of Corfu, Paxos, Ithaca, Kefalonia and Zakynthos which will begin in May 2018. As Ithaca can be readily accessed from the respective islands of **Kefalonia** and **Lefkada**, both of which are renowned for their European Blue Flag beaches, the hiring of a car to take advantage of island hopping possibilities is often seen as a useful option.
